The editor in chief of the e-Journal is Prof. Dr. Tri Bikram Bhattarai.


NEGAAS Monthly Meeting








NEGAAS's International Women's Day Celebration

He has successfully defended PhD Dissertation in Water and Climate Change and awarded Doctor title from Tribhuvan University of Nepal. For the study he he has received three different scholarships to attend short research course in Germany. Firstly, DAAD Re-Visit Fellowship Program at University of Applied Sciences, Faculty of

Civil Engineering, Detmold, Germany. Secondly, he participated in the foundation course on Climate Change Adaptation and Mitigation at Humboldt University, Berlin, Germany and thirdly Water Resource Management and Climate Change Adaptation CIPSEM course at Technical University of Dresden, Germany. Those Fellowships

and course has materialized his dream towards in-depth research on water and climate change, under the supervision of internationally renowned Professor in scientific manner; which has concreted my pathways PhD degree.

Additionally, on his leadership role successfully organized the Climate Change Induced Water Disaster: 'case of 2021 Melamchi River flooding Sindhupalchok' 1-6 Nov. 2022 Dhulikhel, Kavrepalanchok Nepal. There were 25 participants from DAAD Alumni from South and South East Asian Countries: Nepal, India, Bhutan, Bangladesh, Myanmar, Indonesia and Vietnam. There were five local participants from Melamchi Municipality and Helambu Rural Municipality of Sindhupalchok. After six days of concentration and discussion on thematic groups and field visit, the workshop came-up with the result as a finding. Result is synchronized and published in a poster, the result is handed-over to the local and federal government of Nepal. It

was appreciated that the decisive factor to succeed the event is experience and leadership of program organizer. Participants were highly qualified scientists from the region, and have provided high level thought to come up with concrete findings.

Dr. Meghnath Dhimal was nominated as a member of Expert Group of WHO South East Asia Region on Environment Determinants of Health and Climate Change, New-Delhi, India Also, he was nominated as a member of Wellcome Trust's Health Effects of Heat Interventions Advisory Committee, UK.

On the occasion of national science day, he has received the health sector's Science, Technology and Innovation Award of the Ministry of Education, Science, Technology, Government of Nepal from the Right Honourable Prime Minister of Nepal.

He also served as a Contributing Author of UNFCCC, IPCC sixth assessment report 2022 on Climate Change and Health. Similarly, he has Contributed 32 peer reviewed publications and 9000 citations in 2022 with a total of 24000 citations, h-index 42 and i-10 index 108.

Dr. Babita Paudel



In 2022, she received the prestigious Humboldt Alumni Award from the Humboldt Foundation Germany on the project- Capacity building of female researchers of the STEM field through networking to reduce the gender gap in Nepal. In addition in 2022, she received the "Women in Science and Technology" award from Nepal Academy of Science & Technology.

Similarly, she received travel grant from International Foundation for Science (IFS), Stockholm Sweden. She was invited by IFS as a panelist to discuss on the topic Decolonizing Science -Impacts, implications and recommendation in the recognition of the

UN's World Science Day for Peace and Prosperity. Program was held in Royal Swedish Academy of Engineering Sciences (IVA) Stockholm on November 10, 2022.

In 2022, her team received a National Priority Research Grants on the project - Exploration of genetic diversity and nutraceutical potential of traditionally used wild edible fruits from Kaligandaki and Karnali river corridors. This project is funded by Tribhuvan University, Kathmandu, Nepal and her role is as a Co-PI.

Er. Sandhya Regmi



International Consultant & Project Management Specialist Er. Sandhya Regmi worked in a senior position as Contracts Manager (from Jan 2020 to July 2022) in a 150 km long 'North-South Railway Construction Project in Manila, which is the

largest railway project in the Philippines. The project engages about 2000 experts, engineers and technicians from around 20 countries of the world, where she was the only Nepali engineer in this mega-structured project, which is worth USD

15.8 billion and is funded jointly by ADB and JICA. Sandhya was in-charge of the 2 Contract Packages, each amounting to approx. USD 340 and USD 400 million respectively, for construction of railways, deploying Japanese state-of-the-art technology (rolling stock), sky bridges, tunnels, airports, construction of huge depots on 33 hectares of land including underground railway stations as well as all buildings and stations equipped with security technology operated by automation technology.


